Terms Of Services and Website Use - Private Agreement www.bet-minute.com

This legal binding document – Private Agreement (the “Terms” or the “Contract”) sets out the terms and conditions on which www.bet-minute.com provides you a) the access to its members section (the “Website”) and b) the use of bet-minute tool (the “Tool”). The Terms are covering the use of the Website by all its registered members. By entering into the Website, you agree, without any prejudice and without any limitation, to be legally bound by these Terms.

Any reference to **you** or **your** is a reference to you as a user / member of the Website and / or Service.

1. The Service

2. Your Obligations
